Apply for funding – step by step

If you want to apply for a grant to purchase your electric U-Mobility CARGO, here are all the necessary steps. Please note: Applications for funding at federal or federal state level usually follow the same procedure. However, it may differ at municipal level.

* Documents or evidence to provide vary depending on the subsidy program.

** The maximum permissible period of time between receipt of your approval and your purchase varies depending on the subsidy program. In some cases, you must purchase the bike before the application is submitted.

Write an e-mail with the subject-line 'promotion of commercial activities' to sales.umobility@mubea.com

We require the following information:

- Name of the subsidy program
- Number of desired vehicles
- Your contact details (name and address)

You will then receive your non-binding offer by e-mail.

Submit your application to the competent granting authority!



Many of the authorities providing grants for commercially used e-cargo bikes offer online application, e.g. BAFA (www.bafa.de).

Required documents*:

- Your non-binding offer
- Project description
- Proof of commercial or freelance activity
- Product data sheet
- Letter of attorney, if an authorized representative has been appointed

If you follow the steps precisely, you avoid delays caused by queries.

After successful verification by the granting authority, you will receive your grant notification.

Purchase your U-Mobility CARGO**



You will need the invoice that you receive on delivery of your e-cargo bike, the supply contract, and a photograph of the vehicle to apply to the granting authority (see step 2) for payment of your purchase premium.

- Up to 50 % of the eligible purchase costs depending on the federal state
- Maximum funding of up to € 4,000

MUNICIPAL SUBSIDIES

In counties, cities & municipalities

- Up to 25 % of the eligible purchase costs
- Highly dependent on the funds available

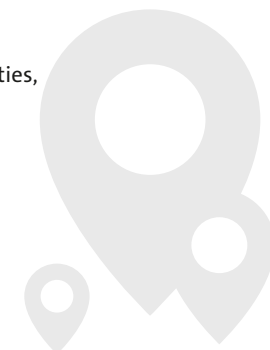
